

Extracurricular Activities

Students in grades three and four are all eligible to join the school choir. Over twenty-five percent of the eligible students participate in this activity. The choir performs for the parents, the school, the PTA, and the community using seasonally appropriate themes for their concerts throughout the school year. A spring intramural basketball program draws in three-fourths of the student body in friendly non-competitive basketball games. The parents participate in helping coach, referee, and cheer for the players' efforts from the stands, creating a positive atmosphere.

Awards and Recognition

The students participate in school-wide spelling, geography, and writing contests during the course of the year. A science fair is held yearly and top art students display their work locally as well as enter pieces for judging in area contests. Students achieving success are recognized with certificates for their achievements. The Music, Art, and Physical Education departments collaborate on a program to display what has been learned in their classes. Parent and community attendance at this program has forced the school to offer four separate presentations in recent years.

What We Are Doing To Improve

The Artist in Residence writing program has assured us of the presence of a writing professional in the building working with students for 48 days in the school year. In addition to working with students, the author completed professional development training with the staff and conducted parent workshops to assist parents, making them better informed about the writing expectations for students.





About Our School

Each child is special. Spencer County Elementary's faculty and staff seek to reinforce that feeling in each of our students enrolled. How is this done? It begins with a cadre of adults welcoming the students who arrive by car. This continues as other adults welcome the students who arrive by bus. The students enter school and go to their choice of the cafeteria, library, or gym to find food, books and computers, or friend-to-friend conversation. Soon students report to their classrooms. Since our elementary is such a large school, the building is divided into nine groups or pods. Six adults serve each of these "families". During the week specialists share music, art, health, and technology skills with each pod. At the end of the school day, teachers escort students to the cars and buses to show how much they care about each child. Making children special makes our school special.

How Our School Ensures Educational Equity

The backbone of the building plan for educational equity is the SBDM committee system. Five committees monitor the educational program by analyzing curriculum, instructional strategies, assessment technique and assessment results, student climate, and long-range planning. Through this composite monitoring, each child is educated in a method and manner that is appropriate for individual instruction.

How Our Students Perform

Kentucky uses the Commonwealth Accountability Testing System (CATS) to hold schools accountable for student progress. CATS has three parts: the Kentucky Core Content Tests, the national Comprehensive Test of Basic Skills (CTBS/5), and other measures of the school's performance, including attendance, retention and dropout rates. Together these three elements make up a school's CATS Performance Score for every two-year period.

Kentucky Core Content Tests

Kentucky's tests rate student performance using four categories: Novice, Apprentice, Proficient, and Distinguished. These categories translate into a scale of 0-140, with 100 being considered proficient. The state goal for all schools is 100 by the year 2014. This chart compares our school's performance with all the schools in our district and all the schools in Kentucky.

National Norm Referenced Test

The national norm referenced test used in Kentucky, the CTBS/5, allows us to compare our students' performance with the performance of students across the country. These scores are reported in percentiles. A percentile of 60 would show that the average student in our school scored equal to or better than 60 percent of all students who took the test.
